#### **RECENT PROJECTS**

Whiskeytown National Park - Numerous Park buildings were destroyed during the Carr Fire during the summer of 2018. Guzi-West provided hazardous waste sampling, asbestos building material surveys, lead based paint surveys, and air monitoring during cleanup and debris removal operations.

**Carr and Camp Fires -** Guzi-West had a team in place that provided everything to homeowners from initial asbestos testing, work plan submittal, oversight of debris and soil removal, to final soil testing and documentation submittals required by local agencies for a clearance to re-build.

#### Bridge Asbestos and Lead Paint Surveys

Guzi-West has conducted numerous bridge surveys for consultants and local agencies regarding the presence of Asbestos Containing Material (ACM) and Lead Paint.

#### Illegal Marijuana Grow Inspection and Testing

At the request of local County building departments, Guzi-West developed a sampling and laboratory protocol regarding illegal indoor grow sites. These sites may have mold issues due to excessive humidity, along with residual pesticides and herbicides.
